## CREDIT AGREEMENT

2. The terms and conditions provided in this agreement shall form an integral part of all present and future contracts of carriage entered into between the parties hereto as evidenced by the terms and conditions contained in the Bill of Lading attached hereto.
3. Further to the terms and conditions of the said Bill of Lading, it is hereby expressly agreed that all freight and charges due shall be paid within the maximum credit term of (d) \_\_\_\_\_ days from the date of the invoice, subject to a maximum outstanding at any one time of (e) \_\_\_\_\_.
4. It is also hereby expressly agreed that the Carrier shall be entitled to all freight and charges of whatsoever nature due and to receive such freight and charges irrevocably under any and all circumstances whatsoever. Such freight and charges due shall be paid in full by the Shipper / Consignee or any other parties and /or any pending claim in respect of such loss or damage to or in connection with the goods shipped.
5. The above terms are in addition to and are without prejudice to the respective rights and obligations of the parties hereto under all present and future contracts of carriage as evidenced by the terms and conditions contained in the Bill of Lading attached hereto.
6. This Agreement shall come into force on the date hereof and shall remain in force without limit in point of time unless terminated by either party hereto giving to the other 7 days prior written notice provided that such termination shall not relieve and party hereto of any antecedent breaches.
